

Your Value-Added Services Are Changing

Thank you for being part of the Molina family! We care about your health. That is why we offer member rewards so you can get the quality care and support you need to stay healthy. At no cost to you!

Each year, your value-added services may change. These changes happen on September 1.

CHIP Value-Added Services Changes (Effective September 1, 2026)

New benefits available September 1, 2026:

- **Rewards for having a follow-up visit after hospitalization**
An additional \$25 for members who have a follow-up doctor visit within 30 days of getting out of the hospital. Available once per year, upon request. Does not apply to newborns being released from the hospital after birth.
- **Allergy-free pillowcase and mattress cover**
Available for members with asthma or COPD who are enrolled in Molina's Case Management program for at least three months. Available once per year, upon request.
- **Pest repellent wall plugs**
For members with asthma or COPD who are enrolled in Molina's Case Management program for at least three months. Available once per year, upon request.
- **\$15 reward for email/text opt-in:** For new members who opt in to email or text communications as head of household. Must remain enrolled with Molina for at least 90 days. Available one time only, upon request.

Benefits no longer available on September 1, 2026:

- **\$20 for vaccines**
For members who get the DTap, flu, pneumonia, and rotavirus vaccines by their second birthday. Available one time only, upon request.
- **\$25 for HPV vaccine**
For members who get at least two HPV vaccines by age 13. Must be verified. Available one time only, upon request.
- **WeightWathcers® vouchers**
For diabetic members ages 15 and older with a BMI of 30 and an A1c lab result of 8 or more. Molina will determine the total number of meeting vouchers provided upon request.
- **\$45 for asthma medication**
\$15 reward for members with asthma who refill their asthma-controlled medication four months in a row. Can be requested up to three times per year. Up to \$45 annually. An

additional \$25 reward is available for members who refill their asthma-control medication six months in a row starting September 1, 2025. Available one time only, upon request. Must be verified.

CHIP Perinate Value-Added Services Changes (Effective September 1, 2026)

New benefits available September 1, 2026:

- **Infant car seat**
For members in their sixth month of pregnancy through six months after delivery. Available upon request.
- **\$15 reward for email/text opt-in**
Available for new members who opt in to email or text communications as head of household. Must remain enrolled with Molina for at least 90 days. Available one time only, upon request.

No value-added services are being removed for CHIP Perinate members.
